

Release and Waiver of Liability



PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") executed by the undersigned (the "Volunteer") on the date below in favor of **Recovery Church** and **Cultivating a Coexistence with Animals**, herein, collectively referred to as "**The Woof Roof Project**," should include its owners, managers, officers and employees, the event officials, agents, volunteers, sponsors, and the owners and operators of the venue that will take place on Saturday, December 14, 2019 at the **Recovery Church** facility located at 609 Little York, Houston, Texas 77076.

The Volunteer desires to work as a Volunteer for <u>The Woof Roof Project</u> and engage in the activities related to building dog houses (the "Activities"). The Volunteer understands that the "activities" <u>may include the use of lifting heavy equipment, working with electric equipment, power saw, drill, hammer, roofing nails, screws, measuring tape, paint, wood, and other basic tools for the <u>construction of dog houses</u>. The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:</u>

Release and Waiver: The Volunteer does hereby release and forever discharge and hold harmless Recovery Church and The Woof Roof Project organizers and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the Volunteer's Activities with Recovery Church and The Woof Roof Project organizers. The Volunteer understands that this Release discharges Recovery Church and The Woof Roof Project organizers from any liability or claim that the Volunteer may have against Recovery Church and The Woof Roof Project organizers with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's Activities with Recovery Church and The Woof Roof Project organizers whether caused by the negligence of Recovery Church and The Woof Roof Project organizers or its officers, directors, employees, or agents or otherwise. The Volunteer understands that Recovery Church and The Woof Roof Project organizers do not assume any responsibility for or obligation to provide financial assistance or other assistance including but not limited to medical, health or disability insurance in the event of injury or illness.

Medical Treatment: The Volunteer does hereby release and forever discharge <u>Recovery Church and The Woof Roof Project organizers</u> from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Recovery Church and The Woof Roof Project organizers.

Assumption of the Risk: The Volunteer understands that the Activities included work that may be hazardous to the Volunteer, including, but not limited to, the use of lifting heavy equipment, working with electric equipment, power saw, drill, hammer, roofing nails, screws, measuring tape, and paint. wood, and other basic tools for the constructions of dog houses. The Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Recovery Church and The Woof Roof Project organizers from all liability for injury, illness, death, or property damage resulting from the Activities.

Insurance: The Volunteer understands that, except as otherwise agreed to by <u>Recovery Church and The Woof Roof Project organizers</u> in writing, <u>Recovery Church and The Woof Roof Project organizers</u> do not carry or maintain health, medical, and/or disability insurance coverage for the Volunteer. The Volunteer is expected and encouraged to obtain his/her own health, medical and/or disability insurance coverage.

Photographic Release: The Volunteer does hereby grant and convey unto <u>Recovery Church and The Woof Roof Project organizers</u> all right, title, and interest in any and all photographic images and video or audio recordings made by <u>Recovery Church and The Woof Roof Project organizers</u> during the Volunteer's Activities with <u>Recovery Church and The Woof Roof Project organizers</u> including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings, if any.

Other: The Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. The Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable. The Volunteer represents and warrants that the Volunteer is not a registered sex offender and hereby expressly agrees to a background check at any time.
